

## KEY POINTS

1. Under the charter school law, tuition payments are calculated based on the budgeted expenditures of the student's school district of residence, rather than the charter school's cost to educate a student.
2. **Tuition is not free.** It is paid by tax dollars being sent from school districts to charter/cyber charter schools.
3. Charter and cyber charter schools must accept students from all 500 school districts and, because of disparities in the per-pupil funding formula, they may receive up to 500 different basic education tuition rates and 500 different special education tuition rates.
4. In 2018-19, PA charter/cyber charters are receiving, **on average, \$12,540 per regular education student and \$28,003 per special education student** from Berks County school districts.
5. Berks County school **districts can provide in-house cyber education at a cost that is at least 20% to 30% less than** what they are paying outside cyber charter schools.

6. In 2017-18, Berks County schools spent **more than \$17 million** on cyber charter schools.

7. A school district pays a charter school the same rate for each child with special needs, based on the school district's prior year expenditures, regardless of student differences in educational need, cost, or services provided (PSBA).
8. Special Education tuition payments paid by school districts do not have to be spent entirely on Special Education expenses by charter/cyber charter schools.
9. In almost all cases, school district costs are not reduced when students attend charter/cyber charter schools.
10. For 2016-17, the average total fund balance for Pennsylvania cyber charters is **22.31%** (latest data available from PDE).

## What is the difference between a Charter School and a Cyber Charter School?

### Charter School

Independent public schools established and operated under a charter from the local school board. These schools focus on teacher-led discussion imparted to students through face-to-face interaction at the schools' physical facilities.

### Cyber Charter School

Independent public schools established and operated under a charter from PDE in which the school uses technology to deliver a significant portion of instruction to its students, virtually, without a requirement that students be present at a supervised physical facility, except on a very limited basis, such as for standardized testing.

As a study by the National Education Policy Center (NEPC) concludes, full-time virtual schools – many of them organized as charters – continue to lag behind traditional public schools on graduation rates, Adequate Yearly Progress (AYP), and state performance rankings.

According to the NEPC report, state laws governing the funding and accountability of cyber schools tend to be vaguely-worded, incomplete, and are often not enforced when data is available that suggests a problem exists. The report points to examples in Michigan, Pennsylvania, and Tennessee where aggressive lobbying by for-profit providers circumvented legislative attempts to slow down cyber school expansion in the face of evidence that the schools were underperforming.

The process of identifying schools for support — termed “Annual Meaningful Differentiation” by ESSA—results in two federally-prescribed designations, made at least every three years beginning December 2018:

- **Comprehensive Support and Improvement (CSI):** Schools facing the most significant challenges in academic achievement, student growth, and other areas; and
- **Additional Targeted Support and Improvement (ATSI):** Schools in which performance by one or more student groups is at or below the level of the CSI schools.
